Economic Reforms: Various economic reforms have been implemented to enhance the participation of rural women in the workforce. These reforms aim to provide better access to resources, credit, and land ownership, thereby promoting economic

independence.

Educational Initiatives: Aligarh Muslim University (AMU) has been actively involved in promoting women's education and empowerment. <u>Programs and awareness campaigns emphasize the importance of education, training, and economic self-reliance for women.</u>

Historical Efforts: The Aligarh Movement, initiated in the late 19th century, also played a significant role in advocating for Muslim women's education. <u>This movement laid the foundation for ongoing efforts to improve educational opportunities for women in the region</u>.

These initiatives collectively aim to uplift women in Aligarh by providing them with the necessary tools and opportunities to achieve greater autonomy and participation in society.

The General Assembly on November 7, 1967, adopted a 'Declaration on the Elimination of Discrimination against Women'. The Assembly, in order to implement the principle set forth in the Declaration, adopted a 'Convention on the Elimination of All Forms of Discrimination against Women 'on the 18th December 1979. The Convention is often described as an "International Bill of Rights for Women' and it came into force in 1981.

The Indian Constitution has guaranteed various constitutional rights for them, but due to a lack of awareness, they have been deprived of enjoying those rights. The Government of India has launched various schemes to empower women from this place of discrimination; among them, the introduction of microfinance self-help groups in India in the 1990s was a significant initiative. Almost 50% of the total population is constituted by women in India; therefore, without them, the overall development of the country would never be possible. In this situation, self-help groups have paved the way for women to become economically self-reliant. The International Women Conference, or Women Conference atthe national level,has arranged to provide small loans with much easier conditions than all the conditions required in the case of bank loans. As a result, women are getting connected with economic activities by taking loans easily and ensuring the improvement of their
